MINUTES - RALPHO TOWNSHIP SUPERVISORS REORGANIZATION AND REGULAR MONTHLY MEETING - JANUARY 7, 2013 Held in Municipal Building Meeting Room, 206 S. Market St, Elysburg, PA

Chairman Wetzel called the meeting to order at 6:30 p.m. and led the recitation of the Pledge of Allegiance to the flag.

Chairman Wetzel comment: As mandated by State Law and as advertised this meeting is for Reorganization purposes and the regular January meeting.

Attending were: Supervisors Blaine Madara, William Wetzel, Stephen Major, Vincent Daubert and Daniel Williams. Also attending were: Township Manager Joseph Springer, Solicitor Todd Kerstetter, Township Secretary/Treasurer Debra Olson; Code Officer Mark Lyash; Township Engineer Justin Keister (*arrived at 6:44p.m.*), Police Chief Stu Appel, Roadmaster Howard Shadduck and Justin Strausser from the Shamokin *News Item*.

Changing Chairman is merely following past practice of rotating the position every year so each board member has an opportunity to fill that capacity.

Chairman Wetzel requested nominations for the Chairman's position. Daubert/Madara motioned to elect Supervisor Major as chairman. Chairman Wetzel moved that nominations cease with approval of Major as Chairman unanimous.

Wetzel/Madara motioned to nominate Supervisor Daubert as Vice Chairman. Chairman Major motioned to close nominations with approval of Daubert as Vice Chairman unanimous.

Williams/Wetzel motioned to appoint Joseph Springer, Township Manager; Debra Olson, Township Secretary/Treasurer; Schelsinger & Kerstetter, Solicitor and Larson Design Group as Township Engineers. Motion carried unanimously.

Wetzel/Madara motioned to adopt Resolution 2013-01 establishing the revised engineering fee schedule. Motion carried.

Williams/Madara motioned to appoint Forgett & Kerstetter, certified public accountants for auditing services; and designate township depositories PLGIT and M&T Bank; Charlene Zeigler as Real Estate Tax Certifier, Act 511 tax collector and Delinquent Tax Collector per ordinance. Motion carried unanimously.

Daubert/Madara motioned to appoint Berkheimer Associates Tax Collector for Earned Income and LST taxes; Statewide Tax Recovery for delinquent taxes. Motion carried unanimously.

Daubert/Wetzel motioned to appoint Mark Lyash as Code Enforcement Officer; Tri-County COG Uniform Construction Code Officer and Building Code Officer; Howard Shadduck as Roadmaster; Bill Brior as Primary Sewage Enforcement Officer and Bruce Dobash Alternate Sewage Enforcement Officer. Motion carried unanimously.

The following re-appointments were made on Madara/Daubert motion and carried unanimously: John Yost to a one year term on Township Vacancy Board; Donald J. Spotts, one year term as EMA Coordinator; Joe Pechulis, ZHB 3 year term; Robert L. Dluge, Jr., Esq. one year term as solicitor to Zoning Hearing Board; Ted Yeager, 5 year term to Municipal Authority of Ralpho Township; Mark Lyash 5 year term to Municipal Authority of Sunnyside Overlook.

The following positions remain to be filled: One vacancy on Municipal Authority of Sunnyside/Overlook, 5 year term, term would expire January 2016.

Chairman Major will announce Committee/Department appointments at February meeting.

➢ Notice was received from DEP that the Township was approved for the Act 101 Recycling Program Performance Grant in the amount of \$2,942. This reflects the 345.4 tons of residential and commercial materials recycled by our citizens and businesses in the calendar year of 2010.

CDBG Application Preparation Schedule was approved as presented. It was also decided that SEDA-COG will do request for proposals to hire engineer and solicitor to handle blight demolition and the stormwater channel improvements.

- Report has been submitted to Planning Commission on recommendations for Danson Phase II Subdivision Plan.
- A lot layout plan has been reviewed for Heartland Subdivision Revision and are currently waiting additional information before preparing response to the Planning Commission.
- Engineer Keister cautioned that stormwater channel improvements is a major undertaking and to tread lightly. After discussion the Supervisors understand his concerns and are preparing to use CBDG funds in future years for the project as well.

Chairman Major announced that there would be an executive session for personnel issues and possible litigation at 7:31 p.m. Meeting reconvened at 7:46 p.m.

- Williams/Wetzel motioned to give Debra Olson, Secretary \$.50/hr raise; Howard Shadduck and Wayne Horne, Street Department, \$.50/hr raise per contract; 5 full-time police officers, \$.75/hr raise per contract. Motion carried.
- > Wetzel/Madara motioned to accept agreement with Chief Appel. Motion carried unanimously.
- Madara/Wetzel motioned to give Charles Kowalchick, Buildings/Grounds, \$.50/hr raise. Motion carried.
- > Williams/Wetzel motioned to give Joe Springer, Township Manager, \$1.00/hr raise. Motion carried.

Madara/Williams motioned to sell the 1982 Grader to Penn Township for \$24,399 after speaking on the phone with Supervisor Dan Dorman of Penn Township. Motion carried unanimously. Supervisors thanked Roadmaster Shadduck for his work on helping this deal go through.
