Resolution 2023-13 adopting 2024 Budget was approved on Major/Daubert motion and carried unanimously. General Fund anticipated receipts plus carry over from 2023 = \$2,248,180; budgeted expenditures = \$2,174,067 leaving a projected surplus of \$74,113. State Aid Fund anticipated receipts plus carry over from 2023 = \$380,266 budgeted expenditures of \$230,266 leaving a projected surplus of \$150,000.
