Proposed Budget – Major/Madara Jr. motioned to authorize advertising and posting proposed 2026 budget. Real estate taxes 9½ mills; i.e. general purposes 7¼ mills; fire protection 1½ mill; equipment ½ mill and library ¼ mill; street lighting per assessment formula. General Fund anticipated receipts plus carry over from 2025 = \$2,251,482; budgeted expenditures = \$2,225,352 leaving a projected surplus of \$26,130. State Aid Fund anticipated receipts plus carry over from 2025 = \$513,811, budgeted expenditures of \$433,651 leaving a projected surplus of \$80,160.
